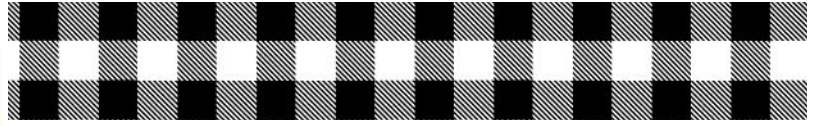

### Our Strategy

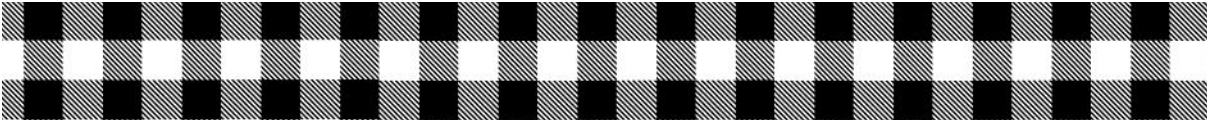
Believing that we are better together, we work in concert with churches and pastors to accomplish these shared objectives:

**ARTICLE 3 - MEMBERSHIP**

3.1 Members of OHIO MINISTRIES with voting privileges shall be as follows:

**3.1.1 Ministers.** All ministers who are in good standing as defined by the state's credentials committee, and are ordained, licensed, or commissioned in the Church of God (Anderson, Ind.) and fulfill any of the following qualifications and declaration thereof by Church of God (Anderson, Ind.) Yearbook registration within the last two (2) years:

- 3.1.1.1 Ministers actively engaged in ministry with Church of God (Anderson, Ind.) congregations in good standing in Ohio.
- 3.1.1.2 Ecumenical ministers actively engaged in ministry while maintaining relationship with OHIO MINISTRIES.
- 3.1.1.3 Retired ministers who maintain identity and affiliation with the Church of God (Anderson, Ind.) in Ohio.
- 3.1.1.4 State Executives and Officers of the Corporation.

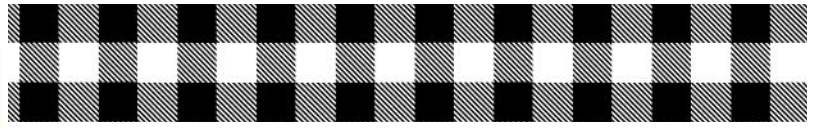
**3.1.2 Lay Delegates.** Lay Delegates selected by their local congregation, under the following formula: one for every one hundred people counted in the local congregation's annualized average weekend worship service attendance published in the current **Church of God (Anderson, Ind.) Yearbook**, not to exceed 10 delegates from any one congregation; such lay members of the Assembly shall have their eligibility authenticated by a written statement (presented to OHIO MINISTRIES) from the sending congregation's lead pastor, interim pastor, or leadership board (in the absence of a pastor) before participation is allowed.

- Working with the Board and other Teams to develop the 120 Fellowship. The focus of this is to spark a disciple-making movement focused within the Church

### Property Sale Proposal

### Discussion

**Terry Morgan** – What will be the accountability of the funds?

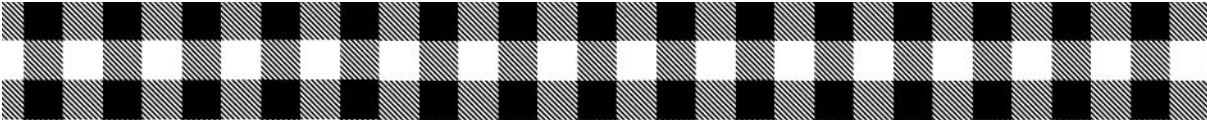
Director Esther Cottrell answered: A portion of the proceeds will be committed for children and youth ministries; an investment team will be appointed to make wise decisions.

**Marvin Schooler** – \$2 million dollars is not a lot of money

**Jack Klinessmith Sr** – was excited by the number of youth he saw at Berlin Center this year. He shared that his two sons were saved at Berlin Center and considers camp sacred ground

**Derek Specht** – he came from a church that detached from a camp property. He believed it is a good idea to save before spending. Specht desired that the GA be kept informed as to how funds will be utilized.





## 2018 Assembly/Governing Board Minutes ~ continued

**Charlene Hubbard** – What prompted the interest in purchasing the property at this time?

**Mark Martin**– Fishburn Farms sold property to Dollar Tree and sought us out to purchase our property for future development. Sale will be finalized in one year, with \$500,000 being placed in escrow. If buyers rescind offer, OM will retain escrowed funds.

**Steve Almquist** – stated that he did not realize that giving to OM was different from Camp Marengo. Director Esther Cottrell answered: The camp is part of the OM budget. Camp monies come from fees and registration from usage, and designated gifts. When the camp runs in the red it comes out of the OM funds. She further reminded the assembly that the robustness of any of the ministries is dependent upon the giving of the local churches. With the sale of the camp, the \$100,000 currently spent annually out of OM general funds to offset the camp funding issues can now be redirected into new adventures in ministries.

**Charles Knowlton** – do we retain the mineral rights  
Esther Cottrell- there are no mineral rights

**Ty Morgan** – one perspective is that there is a group of people that views Camp Marengo as a church and believe that it has been given up on and undervalued. Some people are grieving because of that.

**Dottie Kaiser** – Shared about her family history at Camp Marengo. Recognizing we did not listen to reality and did not fight for it. Now we need to move forward to where the future takes us.

**Marty Cramer** – Her daughter attended camp, worked at OM and was in on how to find ways to make the camp sustainable. She knows there was much intentional energy in keeping the camp a vital reality.

### Budget Presentation by Esther Cottrell

- OM is running behind the budget in church income giving by approx. \$50,000. She asked churches to consider a special end of year offering.
- OM should be able to live within the new 2019 budget with the support of the churches of the Assembly.
- Mark Jackson moved that 2019 budget be accepted. Seconded by Richard Triplett

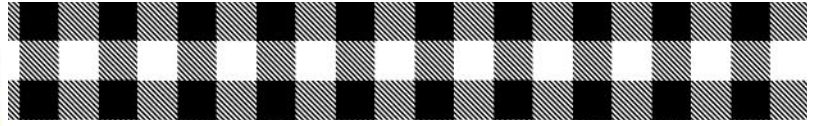

## 2019 Chairman of the Assembly/Board of Directors Report

Thank you once again for the privilege of serving on your behalf.

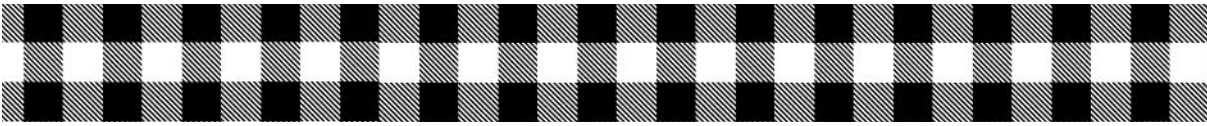

## 2019 State Pastor's Report

Traveling around the Church in Ohio, I see a hunger for something to happen that will propel persons into deeper intimacy with God and closer relationship with one another. I am witnessing pastors forging partnerships with other pastors to bring their congregations together for collaborative ministry. I hear pastors speaking passionately about the need to identify and mentor a new generation of leaders. And I perceive a move to focus God's people on the mission to be multipliers of disciples, leaders, and churches.

This last year has been one of preparing for transition as we begin to write a new chapter for state ministry in Ohio. Many small and big decisions have been made and are being made. At our Board retreat in June we were challenged by our facilitator, David Bartels, to have clarity and intentionality with our mission, values, and vision. As we dug around in that challenge, some key common values surfaced that are informing the state ministry as we move forward into this new chapter. We value **collaboration** of ministry efforts in which the banners of unity and belonging drive new and old partnerships. We value **resourcing** of leaders, congregations, and the next generation of leaders for the Church to produce in their lives and ministries competence and even excellence. And we value **risk-taking** to the extent that we are willing to give up what we have for the opportunity of greater success. **Our mission is to empower and equip the Movement in Ohio per God's Call.** The staff and I have been wrestling with these challenges, seeking scalable and sustainable ways to live into these values and mission. Overviewing our shared ministries, we can categorize these into four areas: leadership development; church transformation; congregational services; and church multiplication. Below are some highlight from these areas of ministry.



### Leadership Development

**Mission 120:** Working with Indiana and Michigan, we have created a powerful pathway to resource and focus pastors and churches to be disciple-making churches. Ohio has committed to raise up 60 pastors and their congregations to participate in this initiative in 2020. The first wave begins in January.

**Credentials:** This last year, the Credentials Committee piloted and reviewed the national manual, noting the most recent changes and editions. They have communicated with the national Standing Credentials Committee their

concerns and recommendations. Based on those exchanges, the Committee fully recommends the ratification of the manual by the Assembly this fall.

This fall, Mike Parks is handing the baton of Leadership Focus Administration to Kim Leach. We are glad that this important ministry will continue to be managed with passion and competence.

**Start Fresh Conference:** Last March nearly 300 clergy and laypersons from every corner of the state attended the Start Fresh Conference. This is a growing opportunity for collaboration of ministry and training for ministry at the lay and clergy level.



### Church Transformation

**A New Team** to focus on Church Transformation was formed. They offer consultation and coaching to pastors and churches seeking a new season of growth and health. The new team consists of Josh Chaffin, Liisa Erskine, Mike Harmon, Iran Watson, and Drew Wilkerson.

**Transformation Process:** We have learned that transformation is more a process than an event, oftentimes taking 8-10 years. We rejoice with churches and pastors that commit to this journey with its powerful rewards. Some of the churches that we partnered with for this journey and are now seeing the fruit are Creston, Connection Point, Church on the Avenue, Bridgewater, Waseon, and West



### Congregational Services

**Summer Youth Camp:** With a mixture of joy and sadness, we completed an outstanding year of summer camping. There was sadness as we realized that camping at the Marengo property was coming to a close. Many memories and events of spiritual significance happened on those grounds. There was also great celebration and joy in the experience of Christian camping. This year we had multiple stories of salvation and call to ministry. Next year we are blessed to have Katlyn Martin serve as our director for the 3<sup>rd</sup> year. We also have a staff that is committed and excited to continue the ministry next year under the new name, COGO Camp at Inspirational Hills in Burbank, OH.

**Celebrating Camp Marengo:** As we close on the property at Camp Marengo, we are grateful for the many persons





who have worked through the years to make the camping a ministry. A special thanks to Dave and Patty Woodward, who have served among us for 21 years. And to Bethanne Martin and the current camp staff who are giving vision and purpose to the next chapter in camping ministry. For our Celebration Day, nearly 200 folks showed up to honor the ministry that happened on the camp grounds and to share stories of God at work to change lives and direct paths for literally thousands over the years.

**OSYC:** Our support of this big event makes a difference in so many lives. I celebrate often the impact that this one weekend has to call youth to the discipleship of Jesus. Jerry Webb, our new convention leader, and his team are expecting several hundred at this year's convention next month at Salem Church of God in Clayton, OH.

**Conditional Deeding:** A joint effort by several state assemblies, in conversation with Church of God Ministries, was to discover and obtain a list of churches in our respective states that were conditionally deeded to the Board of Church Extension and Home Missions. Per the 2012 resolution in the Anderson GA, those deeds were to be transferred to the state assemblies. That has finally been accomplished. Our next step is to work with the Ohio congregations to ensure that their conditional deeds are safeguarded.

**Investment Team:** To steward well the proceeds from the sale of the property and other large streams of income, the Board put in place an Investment Team.



### Church Multiplication

**V2X (Vision to Multiply):** In May 20 pastors gathered, at the joint invitation of Salem pastor Steve Southards and Ohio Ministries, to begin envisioning a multiplication path that is grassroots led and funded. Ohio Ministries and Healthy Growing Churches serve as catalysts and resource agents for this endeavor. It was a hope-filled day that has enthused several of our pastors as they considered how multiplication could be better accomplished as we networked together. The African proverb, *If you want to run fast, run alone. If you want to run far, run together*, articulates well the impact of this gathering. Our next steps are to articulate and commit to common shared goals for multiplication and to determine paths of helpful accountability and resourcing.

**Midwest Multiplication Huddle:** For more than five years Ohio has partnered with Michigan and Indiana to underwrite a quality day of training and encouragement. This event has been in August at the Lima Crossroads Church. This summer we had a record group of nearly 200 pastors and their staff and lay leaders who came together to be resourced in meeting the challenge of making more and better disciples. At that event we commissioned nine teams to plant and/or restart a church/campus. This was a big win for the partnership!



### Sabbatical Reflections

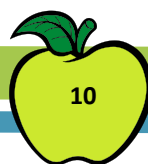
I began the sabbatical anticipating time to reflect with clear vision; to rest and be refreshed in body, mind and spirit; and to hear from heaven as I seek to imagine a preferred future for our shared ministry. As you are aware, the sabbatical experiences took some unexpected turns with the deaths of both my mother-in-law and brother-in-law. While these events certainly have left a mark on this season, I am grateful that I was on sabbatical during this time: available, undistracted, and present to walk with Chris through the initial grief and responsibilities that fell to him as the next of kin. Beyond this, the sabbatical did afford me the opportunity to prepare for a new season of ministry, reflected in our new branding. I was also able to do some focused reading and conversation in the area of building a disciple-making culture as well as stewardship and finance. I believe that as we gear up for this next chapter that the focus of our work needs to be in these areas. Here, we can build a strong ministry, with strong relational ties to pastors and congregations, and a solid financial base. I believe that God is stirring in the hearts of many other leaders in the Church of God similar thoughts and thus I believe that we are on the edge of a new and better chapter. In the words of the old Church of God hymn by DS Warner, "Brighter days are sweetly dawning."

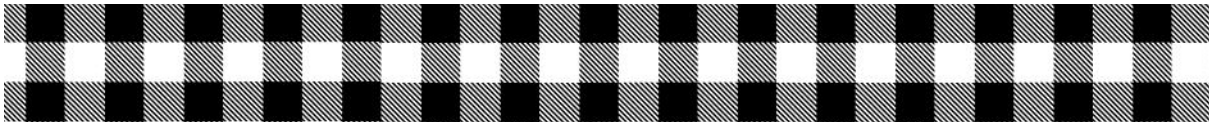

## Mission 120

**Mission 120** is a bold initiative that Ohio, Indiana and Michigan are partnering together to encourage, challenge, and resource 120 pastors and their congregations to prioritize and focus on being a disciple-making church. Believing that disciple-making is at the heart of the call of God on our lives, as proclaimed throughout scripture; and believing that disciple-making is best done in community with one another, you are invited to join this movement. Although the first wave is full, we are looking for pastors and churches to prepare, pray, and participate in the second wave that begins next fall. To help you prepare, pray over, and plan to participate, here are some common definitions:

### Biblical Disciple are...

Intentionally following Jesus

- Obedience to Jesus is the highest priority.
- Publicly declaring being surrendered to Jesus through baptism.
- Loving God and loving others is a way of everyday life.
- Living with the heart and posture of a servant.
- Being generous with all of our resources.

Being changed by Jesus

- Living fully empowered by the Holy Spirit.
- Seeking God's heart and will through listening for His voice in prayer.
- Assuming personal responsibility for our spiritual development through the spiritual disciplines.

Engaging the mission of Jesus

- Actively walking with pre-Christ persons in our relational network to, and across, the line of faith.
- Intentionally being disciplined and making disciples.
- Serving people in the margins of life.
- Actively being the hands and feet of Jesus where we work, live, and play.

### Disciple Making Churches...

**Are led by disciple making pastors**

Disciple making churches are led by pastors who passionately cast a vision for disciple making to third and fourth generations of reproduction. They also lead the way by modeling the posture of Jesus and making disciples who make disciples.

**Have a relational pathway for disciple making**

Disciple making churches have a pathway that produces disciples who make disciples. This pathway is not a program to simply increase spiritual knowledge. It is a spiritual formation pathway that is both intentional and relational with the ultimate goal being obedience followers of Jesus that are living into the great commission.

**Raise up disciples who make disciples, who make disciples**

Disciple making churches will build a culture that raises up disciples who make disciples to multiple generations of reproduction. Disciple making churches are intentionally focused on making both disciples and disciple makers. Every local church has the powerful potential to launch a disciple making movement.

**Send disciples into the mission of Jesus**

Disciple making churches will raise up disciples, disciples makers, every day missionaries, and multipliers. Disciple making churches will build a culture that empowers everyday missionaries to be the hands and feet of Jesus in the places where they work, live, and play. When God provides a call to kingdom work that extends beyond their local church, these disciples will be commissioned and sent to live into that calling.

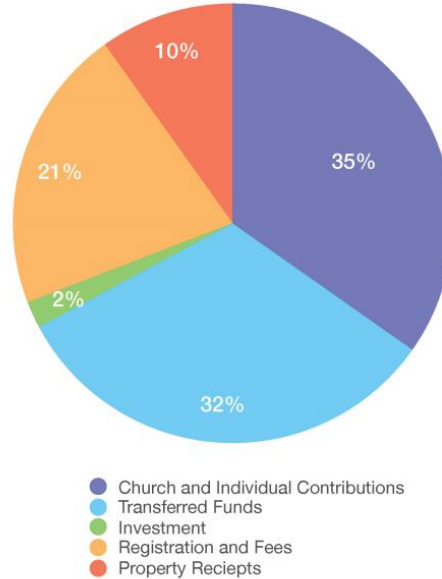

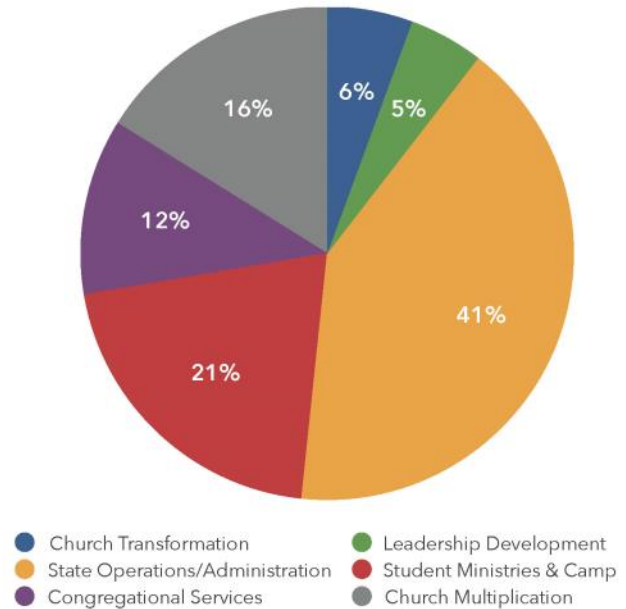
### 2020 Proposed Revenue



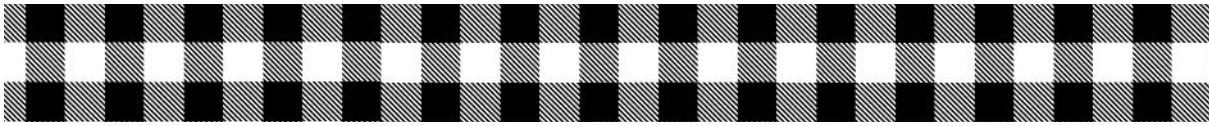

BEGINNING IN 2020, COGO MINISTRIES WILL MAKE AVAILABLE A NON-RENEWABLE MATCHING GRANT TO OUR FIVE OHIO DISTRICTS, AND OUR PARTNERS IN MINISTRY LOCATED IN ANDERSON, INDIANA TO SUPPORT THE MINISTRIES OF CARE AND ARISE).

APPLICATIONS FOR THE COGO MATCHING GRANTS WILL BE AVAILABLE BEGINNING JULY OF 2020 AND AWARDED DURING THE 2020 AND 2021 STATE GENERAL ASSEMBLY. THE AMOUNT OF THE INDIVIDUAL GRANTS WILL BE AWARDED BY A COMMITTEE CALLED COGO GRANT.

Leadership Focus is the credentialing tool used within the Church of God. It is a 6-module curriculum to support the credentialing requirements in the Credentials Manual of the Church of God and is designed to prepare leaders for ordination. The module themes explored are:

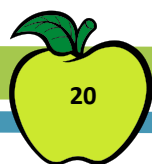
- [1] COMMENCEMENT Knowing God's will for me;
- [2] CHARACTER Knowing the personal me and aligning with the Holy spirit for missional purpose; [
- [3] COMPETENCIES Knowing the public me and interacting with others to unlock their potential for missional kingdom impact;
- [4] CONFESSIONS Knowing the professional me and developing skills to communicate missional truths that transform lives;
- [5] CONNECTIVITY Knowing the partnering me and intentionally developing healthy kingdom relationships that produce missional expansion;
- [6] CELEBRATIONS Knowing the integrated me and articulating God's will (calling) for me in a missional focused LAMP.

Candidates are assigned to a cluster group that they will "journey" with throughout a nearly 3-year process; each cluster is comprised of 3 to 5 individuals from a variety of locations across the country. An experienced coach is assigned to the cluster for each module; cluster coaches change for each module. Candidates will review and complete assignments, access general module resources, and track progress using the Leadership Focus Portal (<https://www.choglf.org>); each module is 6 months in duration with the exception of the first module, Commencement, which is primarily an orientation module and is partly self-paced. At the end of the process, a candidate will have spent a little more than 2.5 years with their cluster group members, guided by 5 different coaches.

### Excitement #2:

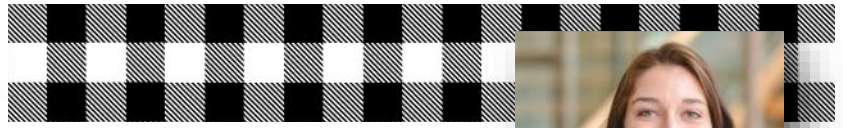
