EQUIPPING AND EMPOWERING FOR THE MISSION OF JESUS

ARTICLE 3 - MEMBERSHIP

3.1 Members of OHIO MINISTRIES with voting privileges shall be as follows:

3.1.1 Ministers. All ministers who are in good standing as defined by the state's credentials committee, and are ordained, licensed, or commissioned in the Church of God (Anderson, Ind.) and fulfill any of the following qualifications and declaration thereof by Church of God (Anderson, Ind.) Yearbook registration within the last two (2) years:

- 3.1.1.1 Ministers actively engaged in ministry with Church of God (Anderson, Ind.) congregations in good standing in Ohio.
- 3.1.1.2 Ecumenical ministers actively engaged in ministry while maintaining relationship with OHIO MINISTRIES.
- 3.1.1.3 Retired ministers who maintain identity and affiliation with the Church of God (Anderson, Ind.) in Ohio.
- 3.1.1.4 State Executives and Officers of the Corporation.

3.1.2 Lay Delegates. Lay Delegates selected by their local congregation, under the following formula: one for every one hundred people counted in the local congregation's annualized average weekend worship service attendance published in the current **Church of God (Anderson, Ind.) Yearbook**, not to exceed 10 delegates from any one congregation; such lay members of the Assembly shall have their eligibility authenticated by a written statement (presented to OHIO MINISTRIES) from the sending congregation's lead pastor, interim pastor, or leadership board (in the absence of a pastor) before participation is allowed.

At the 2023 General Assembly we set forth the challenge to live and plan our ministry focused on our mission, equipping and empowering churches and pastors to be disciple-makers. Wherever I go, whether talking with lay persons, pastors, our national leaders, missionaries, or denominational leaders the common theme is the deep felt need for the Church to address and focus on this one thing: being the Church that makes disciples. The Church of God in Ohio must make disciple-making our priority if we are to be Kingdom worthy. With that in view there are several programs and initiatives that have been on the COGO agenda this year. In this report, with thanksgiving to God, the COGO staff and I offer the following:

Leadership Development

1. Start Fresh, a one day conference for lay leaders and pastors, focused on disciple-making.
2. The COGO Podcast, hosted by RW Moody, incorporated good disciple-making information and guests.
3. 64 Ordination Candidates are currently enrolled in Leadership Focus and 10 persons are being recommended today for ordination this year.
4. Over 20 Gen Z persons were identified this summer as persons experiencing and investigating a call to ministry. Our NxtGen Ministry is working with 3SLI, Intern Academy, Trellis, and our colleges to develop opportunities for these newly called to develop in their calling.

Church Multiplication and Transformation

1. COGO hosted a one-day conference with Intentional Church in April for 8 -10 churches to train in disciple-making at the grassroots.
2. Start Now, Go Now ran through Pentecost. The purpose of that initiative was aimed at encouraging pastors and churches to count and celebrate our evangelistic and discipleship efforts. Approximately 20% of Ohio churches participated in reporting baptism and persons on a discipleship pathway. Average per church was 8 conversions, 14 baptisms, and 8 persons involved in an intentional discipleship pathway reported. Additionally, we continue to have reports from across the Ohio of the Lord of the Harvest working among us as the church focuses on disciple-making.

3. The Midwest Multiplication Team of Illinois Ministries, Indiana Ministries, the Church of God in Michigan and COGO have a shared goal to plant 32 churches in 3 years between 2023-2026. This goal is called Launch 32. Ohio committed to launch 11 new churches, replants, fresh expressions and/or missional communities. God has been faithful and we are on target to meet that goal. Our score card of 9 includes: plants- Restauración Shalom in Springfield, and Kettering House Church; restarts and campuses - Liberation Church, Common House, Pymont, Snyder Road, and Ashland; microchurches or missional communities at Connection Point and Kingswell. We know that not all our efforts will be successful yet if we risk nothing, we will gain nothing.
4. Ohio, Indiana, Michigan, Illinois and Texas state ministries also entered a contract with NewThing and Healthy Growing Churches to be trained and coached in developing networks focused on guiding churches and pastors to make disciples, develop leaders, plant churches, and initiate planting movements. A goal for 2025 is to create 3 networks of 3-5 pastors in Ohio.
5. Our partnership with Planting Together continues to be a promising opportunity. This summer 15 persons, called to plant Spanish language churches completed an intensive planting program. Some of those persons are working with Planting Together and COGO to plant in Ohio.
6. The Miami Valley Multiplication Network (formally called Vision to Grow-V2x) spent a day to reorganize and clarify the vision, values, and purpose to continue collaborating.
7. COGO is a partner supporter of the Church Multiplication Webinar Series that the School of Theology has created. The first in the series was April 16-17. We developed several watch centers around our state for pastors to gather, watch and discuss. Six watch centers and over 40 pastors and lay leaders participated. The next opportunity for you to participate in this free-to-you webinar is February 26, 2025.

Launch 32 Conference

A MULTIPLICATION CONVERSATION

Project F.E.E.D.

In 2025, COGO continues to focus on our mission. To focus on the mission and to address the issue of a leadership pipeline that is too thin to handle the growing need, a new initiative called Project F.E.E.D. (Find, Embrace, Equip, and Deploy) kicked off this fall. The focus of this initiative is to encourage and give handles to pastors and church leaders in the raising up and deploying of new leadership. It is designed to build on Start Now, Go Now. COGO is convinced that the path to dealing with the leadership pipeline issue is to proactively engage the Church in the identifying, calling, developing and sending leaders into the Harvest to pastor current and future churches. Will you join us?

Staff News

Sabbatical 2023 was an excellent experience. Both Chris and I were encouraged as we toured Europe to see our Church at work. Our hearts were deeply touched as we met Ukrainian refugees and heard their stories; met our German brothers and sisters who have taken these folks into their homes and churches; and seen our humanitarian aid system at work to help our brothers and sisters still in Ukraine. These were parts of the sabbatical that beyond the joy of sightseeing, have given us most meaning from the sabbatical days. Thank you for your support of this time.

Beginning in December, the Board has approved me to take the remaining 6 weeks. Using the timing of the holidays works well within the COGO calendar and the needs of the Ohio churches as well as with the national duties I hold as chair of the General Assembly.

Kyna Shindle retires at the end of this year. With more than eight years of faithful and creative service as our administrative assistant, Kyna is looking forward to camping, engaging in arts and crafts, and spending time with family. We are so grateful for her ministry among us and ask God's blessings on Kyna in this new chapter of her life.

Becky Heller joined our team in July as our new administrator assistant. She is a great choice to succeed Kyna in this role, bringing a wealth of experience and passion for the ministry. Becky has been working with Kyna this summer to learn the position as well as bringing her skills and creativity to the job. In the coming days you will see her handiwork as she owns various pieces of the job description.

And as our chair, Matt Roe, has already indicated, **Demetrius Booker informed me earlier this year that he plans to retire** in August, 2025. Demetrius has served with distinction and commitment to COGO and the Ohio churches since he joined the team in 2016. His commitment to serve us with excellence continues. I am confident that he will finish strong and well this ministry assignment.

Matt also indicated that, **I have informed the board of my decision to retire at the end of 2025**. After careful thought, prayer, and conversation with Chris I am convinced that this is the right time. By the end of 2025 I will have served 23 ½ years in state ministries for Ohio, 10 of those years will be as state pastor. It has been one of my greatest joys in life to serve in this ministry. I have often thanked the Lord for the privilege of working among some of His choicest servants. I will leave this ministry with a grateful heart!

As I reflect on my tenure as state pastor it is with a sense of joy and hope. Joy for the progress we have made as we have focused on equipping and empowering pastors and churches for the mission of Jesus. And hope because I see that the conversation and focus in our healthy churches and pastors is on the mission of Jesus. During my tenure we have weathered a pandemic that re-focused this ministry to equip the Church in practical ways as we navigated getting online, then coming back to in-person worship, decisions and process for getting PPP, and dealing with the sense of isolation, rebuilding, etc. etc. But before and after the pandemic we walked through a lot of change with the sell of the camp and relocation, re-branding to COGO from Ohio Ministries, staffing for the mission, focusing our ministry to the 4 areas of Church multiplication, Church transformation, leadership development, and congregational services. In each of these areas we have seen great victories. Church multiplication has planted both English and Spanish language churches, replanted dying churches, opened the door for the grassroots planting, and expanded our partnership with surrounding state ministries. Church transformation gave new life to congregations seeking a new life cycle and mission focused purpose through coaching and programs like Mission 120 and Start Now Go Now. Leadership development is at the core of events such as GA, webinars, Launch 32, OSYC, and Start Fresh and Project F.E.E.D as well as the credentials ministry including Leadership Focus. And in the congregational services area attention to the

NXTGen Ministries, Disaster Relief, helping congregations with legal and financial matters all play a role in what we have been able to accomplish together.

Although this has been a difficult decision it is a good one. Chris and I are looking forward to quality grandparenting time. And with my departure, COGO is positioned to write a new chapter. I am confident that the Search Committee will serve you well and with the wisdom of our Lord to guide them, will select to present to you an anointed leader to take Ohio to a greater level of ministry. But throughout 2025 I commit to you that my aim and goal is to finish this ministry well and ready to hand off to your next leader. To God be the glory!

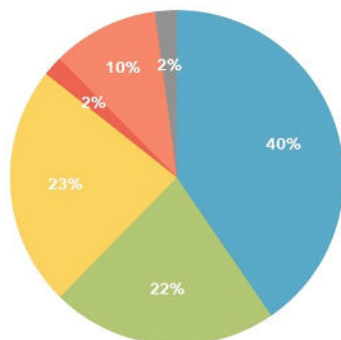

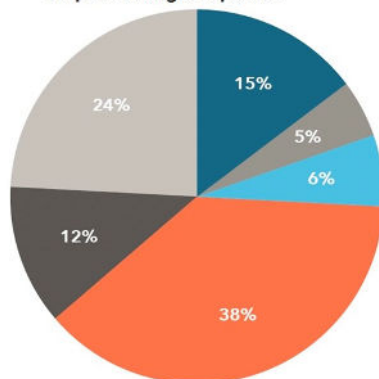

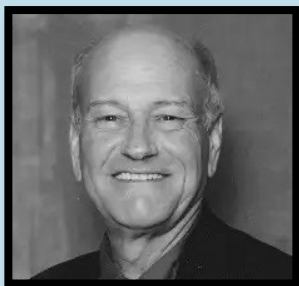

(Unusual circumstances such as Covid, or other events that interrupt the normal activity of said sub-account and/or project.)

At which time the funds in said sub-account will be transferred to the General Disaster Relief Fund.

The individual/company charged with the book-keeping of COGO Ministries financials shall be notified of said action in writing, so as to provide a trail for future reference.

The above action was approved by the Disaster Relief Team on October 22, 2022 with a vote of 6 to 0 in favor. (One member: Not present at the meeting and did not respond to the email.)

We want to thank COGO Ministries for their concern and generosity to help us meet the needs in Western NC. Your gift has helped us to resource churches who are on the front lines as they minister to the communities impacted by the hurricane. Water and food have been in short supply.

Churches in Morganton, Drexel, and Asheville are distributing water. Rock Chapel in Granite Falls host work teams to help with clean up and repair of homes. Morganton First Church is distributing clothes and kerosene heaters, serving meals and praying with those without electricity, and with first responders, and power line workers; . Alta Pass Church Spruce Pine, NC is a distribution center and is prepared to host work teams.

Asheville has old water pipes that must be replaced. It is estimated that it will take 30-60 days before water will be restored to 80% of Asheville. In the mountain communities, the power grid has been destroyed and needs to be rebuilt which is delaying power for months in some communities.

Our churches are very grateful for your support! We have been amazed at how the Church of God has reached out to help in such a generous way! It has helped to meet needs and has provided many ministry opportunities. Please continue to pray that the churches will be able to have a spiritual impact as they help meet the physical needs.

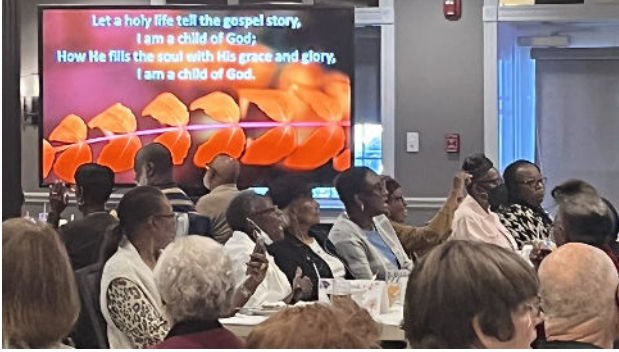

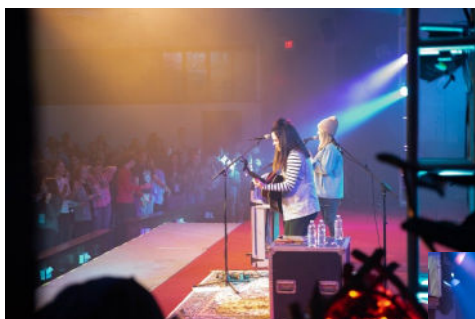

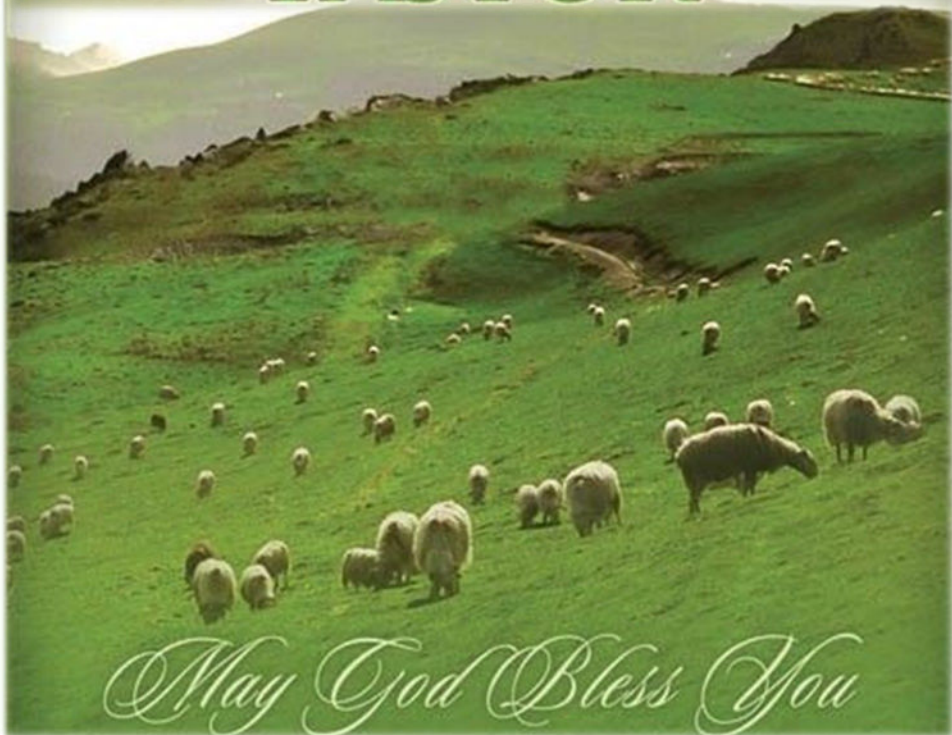
